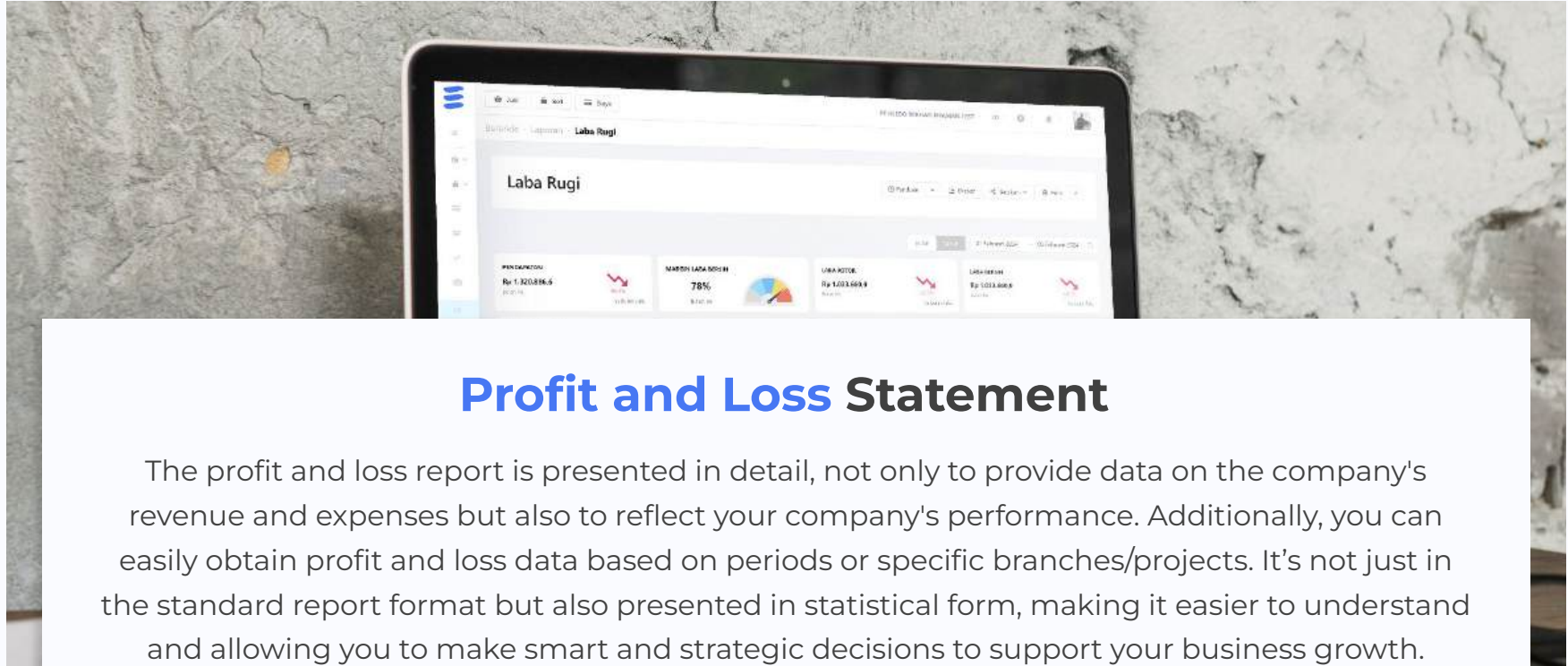


Balance Sheet
